

This document contains key information you should know about the Series D units of Caldwell Balanced Fund (the "Fund"). You can find more detailed information in the Fund's simplified prospectus. Before you invest in any fund, consider how the Fund would work with your other investments and your tolerance for risk.

Subject to unitholder approval, Caldwell Investment Management Ltd. proposes to change the investment objective of the Fund effective on or about November 16, 2020 to permit the Fund to invest substantially all of its portfolio in equity securities of Canadian and international companies. In conjunction with the proposed investment objective change, once approved and implemented, the name of the Fund is expected to change to Caldwell North American Fund.

The charts below give you a snapshot of the Fund's investments on September 30, 2020. The Fund's investments will change.

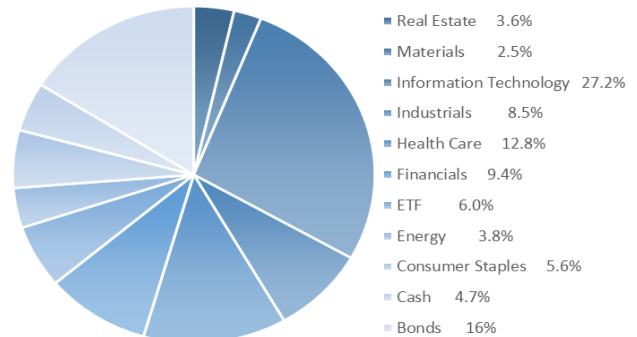

How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.



Risk rating

Caldwell Investment Management Ltd. has rated this Fund's risk as **low to medium**. This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

No guarantees

Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.

How has the Fund performed?

This section tells you how the Series D units of the Fund have performed. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

Year-by-year returns

Who is this fund for?

Investors who:

- have a long term investment time horizon
- want the stability and income of Canadian government bonds combined with the growth potential of senior Canadian and American corporations



Don't buy this Fund if you have a short term investment time horizon of less than 3 years.

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much income tax you pay depends on the tax laws where you live and whether or not you hold the Fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series D units of the Fund.

The fees and expenses – including commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds, series and investments that may be suitable to you at a lower cost.

1. Sales charges

No sales charges apply to Series D units of the fund.

2. Fund Expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns.

The Fund's expenses are made up the management fee (including the trailing commission), operating expenses and trading costs. The annual management fee for Series D units is 1.25% of the series' value. Operating expenses and trading costs are not yet available for Series D units of the Fund since no Series D units were outstanding as of the last completed financial year of the Fund.



More about the Trailing Commission

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and/or advice that your representative and/or their firm provide to you.

Caldwell Investment Management Ltd. pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. The rate of commission is up to 0.25% of the value of your investment each year. This equals \$2.50 each year for every \$1,000 invested.

3. Other Fees

You may have to pay other fees when you buy, hold, sell or switch units of the Fund.

| Fee | What you pay |
|------------------------|--|
| Short-term trading fee | 2% of the value of units you sell or switch within 90 days of buying them. This fee goes to the fund. |
| Switch fee | Your investment firm may charge you up to 2% of the value of units you switch to another Caldwell Mutual Fund. |

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
