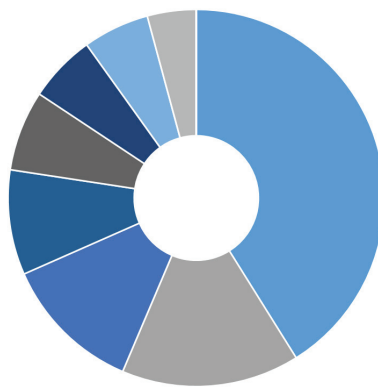
- Attractive yield paid monthly, plus capital appreciation potential

¹The Fund was first offered to the public as a closed-end investment since May 28, 2015. Effective November 15, 2018 the Fund was converted into an open-end mutual fund such that all units held were redesignated as Series F units. Performance prior to the conversion date would have differed had the Fund been subject to the same investment restrictions and practices of the current open-end mutual fund. Management fees have not changed and expenses will be capped such that the Manager does not anticipate the MER in 2020 to exceed 1.85% for Series A units.

²As at December 31, 2020. Active Share, represents the proportion of portfolio holdings that differ from those in the benchmark (S&P/TSX) Index. It is calculated as the sum of the absolute difference in allocation between each portfolio security and Index constituent, divided by two.

³Sector Allocations, determined internally, include Cash.
